PURPOSE AND LEGAL BASIS. Please be advised that the data will be processed for the following purposes:

This processing of data will always be based on the principles of fairness, lawfulness, transparency and protection of the confidentiality and rights of the data subjects.

RECIPIENTS OR GROUPS OF RECIPIENTS. The personal data may be processed exclusively by the Controller or persons authorised by the latter.

The data in question may be transferred to the following groups of third parties:

GROUPS OF PERSONS TO WHOM THE DATA OR PARTS THEREOF MAY BE TRANSFERRED
Consultants, professionals and service providers, necessary for the purposes indicated, who process the data as Data Processors, with whom the Agreement pursuant to art. 28 GDPR.
Independent data controller, whose data processing indicates is necessary for the purposes indicated.
Public authorities, to whom the communication is required by law or by order of the Authority

The data shall not be disclosed, within the limits of the aforementioned purposes.

LOGGING A COMPLAINT WITH THE SUPERVISORY AUTHORITY. The data subject is entitled to lodge a complaint with the Supervisory Authority (for Italy: Garante per la protezione dei dati personali www.garanteprivacy.it).

RIGHTS OF THE DATA SUBJECTS. It is possible at any time, to exercise the rights to access personal data, rectify or erase the latter, restrict processing, object thereto or to processing portability according to articles 15-20 of European Regulation 679/2016 by sending an e-mail to the following address: info@leterredeisavoia.it.

The exercise of the rights of the data subjects could be delayed, limited or excluded in the cases provided for by art. 2-undecies of Legislative Decree 196/03.
